She has served on numerous boards, including Te Rūnanga o Ngāti Pikiao and Aotearoa Fisheries Ltd and participated in the Fisheries Settlement arguing the case at the Privy Council. She is currently an advisor to the Ministry for the Environment on Māori rights in freshwater management and is a trustee on Crown Forest Rental Trust

Her contributions were recognised this year winning the Access to Justice Award from the NZ and Australian Bar Association and received the Lifetime Membership Award from Te Hunga Rōia Māori. Her contribution to TALT would be immeasurable.
